CIRCULAR

Subject: Payment of inspection fee to the accreditation agencies – reg.


As per the procedure of accreditation, the applicant has to pay the fee for accreditation to accreditation agency directly alongwith the request for accreditation of his warehouse. The applicant warehouse has also to submit all the documents essential for accreditation/registration to the accreditation agency.

Further in this regard following accreditation fee structure was already communicated to the concerned accreditation agencies:-

- A. Warehouse with capacity upto 10,000 MT:-**
For two visits in 1st year Rs. 15,000/- + service tax
- B. Warehouse with capacity over 10,000 MT:-**
For two visits in 1st year Rs. 21,000/- + service tax

In this regard, since the accreditation fee is for two visits of the agency, it is hereby clarified to all applicant warehouses/registered warehouses to make payment for each inspection separately, so that whenever accreditation agency plans the inspection, (as per the guidelines of WDRA being issued from time to time) then every time the fee may be given to the accreditation agency as follows:-

- A. Warehouse with capacity upto 10,000 MT:-**
For one visit -- Rs. 7,500/- + service tax
- B. Warehouse with capacity over 10,000 MT:-**
For one visit -- Rs. 10,500/- + service tax
